MINUTES OF REGULAR MEETING VARNER CREEK UTILITY DISTRICT

June 19, 2013

The Board of Directors of Varner Creek Utility District of Brazoria County, Texas convened in regular session, open to the public in the Board Room at the Columbia Lakes Clubhouse, West Columbia, Texas within the boundaries of the District on the 19th day of June, at 9 a.m. and the roll was called of the duly constituted officers and members of the Board, to-wit:

All members were present, except Director Pollard thus constituting a quorum.

Also present were the following: Debra Lanehart, 1st Capital Business Services; Denise Kemp, City of West Columbia; Morris Ryder, Ryder & Co.; Geneva West, CLHOA; Robert Bagley, Baker & Lawson

Director Sauer called the Regular Meeting of the Board of Directors to order.

A. TRUST PROPERTY: No bids were received for VCUD trust property.

C. STANDBY, WATER AND SEWER BILLING AND COLLECTIONS REPORT

1. Debra Lanehart reported the collections for standby in May totaled \$1,233.00. The spreadsheet for VCUD/CLHOA collections contained an error in the formula, which will be corrected for the next report.

Director Gillenwaters made the motion to accept the standby collection report. Director Sassin seconded the motion and the vote was unanimous.

2. Denise Kemp presented the water and sewer billing and collections report.

C. STANDBY, WATER AND SEWER BILLING AND COLLECTIONS REPORT CONT.

Accountability for the month was 83% for read dates 4/18-5/20/13. Total pumping reported by Ryder & Co. was 5,298,000 and consumption totaled 4,437,200.

The cut-off list was presented; cut-off for delinquent accounts is scheduled for June 26, 2013.

Director Sassin made a motion to approve the cut-off list, seconded by Director Pell, and the vote was unanimous.

Director Gillenwaters made a motion to accept the water and sewer reports, seconded by Director Sassin, and the vote was unanimous.

3. Geneva West requested an abatement of the penalties paid by Dr. Voltz when reinstating the Swimming Pool Account previously under William Verkin's responsibility. A total amount of penalties paid was not available at the meeting. The Board tabled the request until the next meeting.

D. ADMINISTRATOR REPORT

1. Debra Lanehart, District Administrator, presented her report reviewing account monies, transfers and balances in the District's Operating, Capital Projects, and Debt Service accounts.

Motion made by Director Pell to accept the cash report as given, seconded by Director Sassin, unanimous approval.

2. Certified Tax Assessor report for May 2013 was presented. Current year collections for the month were \$14,142.13 and delinquent collections for the month were \$1,124.90

Motion to accept the Tax Assessor report made by Director Gillenwaters, seconded by Director Pell and the vote was unanimous

3. Debra Lanehart presented the Board with an updated Application for Water Tap and Sanitary Sewer Service, which reflect any changes in procedures.

The motion was made to accept the updated Application as presented by Director Sassin, seconded by Director Pell and the vote was unanimous.

4. Commercial Property Tax Status Report: Debra Lanehart provided the Board with and updated tax status report by entity for consideration.

D. ADMINISTRATOR REPORT CONT.

5. Consumer Confidence Report: Debra Lanehart provided the Board with copies of the Annual Drinking Water Quality Report.

Director Pell made the motion to approve the report for distribution. Director Gillenwaters seconded the motion and the vote was unanimous.

- 6. A motion to set the Public Participation Discussion of the report for the July 17 regular meeting at 9:00 am was made by Director Sassin. Director Gillenwaters seconded the motion and the vote was unanimous.
- 7. 1996 Series Bond: Joe Morrow with First Southwest provided a summary outlining the ramifications of paying either \$125,000 or \$200,000 of principal on the 1996 Bond.

Director Pell made the motion to call the full 2016 principal maturity of \$125,000 and partial 2015 principal maturity of \$75,000 on the 1996 Series Bond in addition to the August 2013 principal payment of \$100,000 and interest payment of \$11,812.50. Director Gillenwaters seconded the motion and the vote was unanimous.

Director Gillenwaters made the motion to accept the minutes of the May 15th meeting as presented. Director Sassin seconded the motion and the vote was unanimous.

Director Pell made the motion to identify the needed repairs to the manholes and subcontract the work to Standard Cement Materials, Inc. Director Gillenwaters seconded the motion and the vote was unanimous.
