Director Sauer called the Regular Meeting of the Board of Directors to order.

A. TRUST PROPERTY: No bids were received for VCUD trust property.

B. STANDBY, WATER AND SEWER BILLING AND COLLECTIONS REPORT

1. Debra Lanehart reported the collections for standby in November totaled \$1,977.00.

Motion to accept the standby collection report was made by Director Pell, seconded by Director Pollard and the vote was unanimous.

2. Debra Lanehart presented the water and sewer billing and collections report. Accountability for the month was 83% for read dates 10/19 - 11/23/2012.

Motion to appoint a replacement for Director Gius' full term made by Director Pollard, seconded by Director Gillenwaters and the vote was unanimous.
